# Digital Cover Art License Agreement (Commercial License)

**Effective Date:** Upon purchase of any digital product.

**Licensee:** Individual or legal entity (company) purchasing the artwork.

**Products Covered:** Pre-made digital cover art files sold by Nibera Visuals.

By purchasing and downloading any digital artwork from Nibera Visuals, you (“Licensee”) agree to the following licensing terms:

---

## 1. Grant of License

Nibera Visuals grants the Licensee a **non-exclusive, worldwide, perpetual, and non-transferable commercial license** to use the purchased digital artwork (“Licensed Artwork”) under the conditions below.

This license **does not transfer ownership or copyright** of the artwork to the Licensee. All rights not expressly granted herein are reserved by Nibera Visuals.

## 2. Permitted Uses

### 2.1 Commercial End Products

You may use the Licensed Artwork in **physical and digital end products** for commercial purposes. Examples include:

- Album or single cover art
- Posters, flyers, or merchandise packaging
- Promotional items (stickers, cards, etc.)
- Digital marketing (social media, websites, blogs)

**Quantity Limitation:** Up to **5,000 combined lifetime sales or instances** of end products incorporating the Licensed Artwork. For higher quantities, contact Nibera Visuals for an extended commercial license.

## 2.2 Social Media and Promotion

- One company's social media account may use the artwork for commercial promotion.
- Physical advertisements are allowed within a **local market** ( $\leq 200$  miles within a single country).
- Digital advertisements (social media, web banners, online ads) are permitted **without limit**.

## 2.3 Broadcast and Streaming

- The artwork may be used in audiovisual content, music videos, or promotional videos.
- Commercial broadcast viewership limit: **500,000 lifetime viewers**.
- Non-commercial streaming has no viewer limit.

## 3. Prohibited Uses

You may **not**:

1. Resell or sublicense the original artwork as a standalone file.
  2. Use the artwork in on-demand products (print-on-demand, made-to-order, download-on-demand).
  3. Use the artwork as a trademark, service mark, or design mark without significant alteration.
  4. Claim copyright or authorship of the original artwork.
  5. Use the artwork in pornographic, defamatory, illegal, or offensive material.
  6. Make the artwork available for download, extraction, or redistribution as a standalone file.
  7. Use the artwork in a manner not expressly permitted in Section 2.

## 4. Attribution

Attribution is **not required** for commercial use. For editorial or public use, credit is appreciated:

## 5. Ownership

Nibera Visuals retains all ownership and intellectual property rights. Purchase of the artwork **does not transfer copyright** to the Licensee. This license grants the right to use the artwork as described above.

Nibera Visuals may terminate the license if you breach any terms. Upon termination, you must:

- Stop using the Licensed Artwork
  - Delete all copies of the Licensed Artwork
  - Ensure any clients or service providers do the same

The artwork is provided “as is.” Nibera Visuals is not liable for any damages arising from the use of the Licensed Artwork. Maximum liability is limited to the purchase price paid for the artwork.
